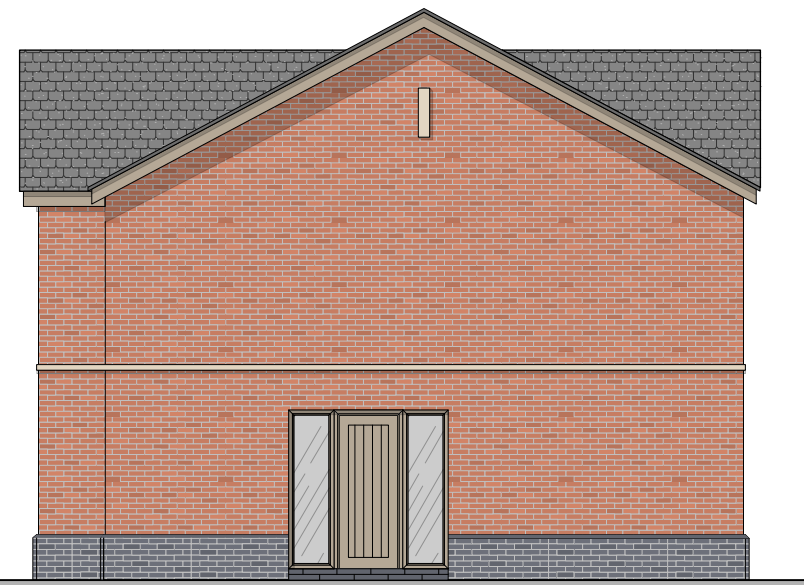
1 **Front Elevation**

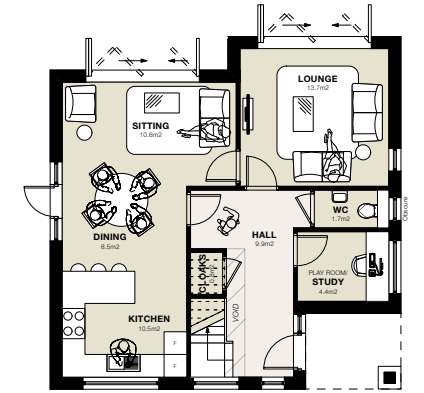
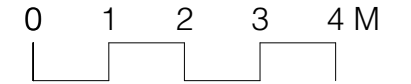


4 **Side Elevation**

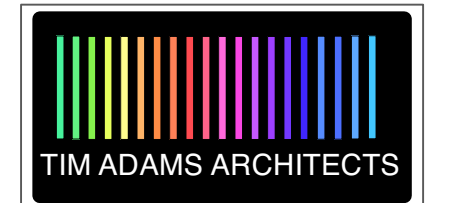
